Provisional and the voter or the election of money or any other object of value to vote for any particular candidate, list of candidates, issues, or list of issues included in this election constitutes an act of voter fraud and is a felony under Georgia law. (O.C.G.A. 21-2-394(a), 21-2-395(a) and 21-2-392(a))
